
This year has already started with Australia Day.

SECRETARY'S REPORT

How many other theatre groups can say that they:

- started in 1947 and have continuously produced plays ever since
- have owned and operated their own theatre since 1965
- have had a junior theatre arm since 1974
- have had a youth theatre arm since 2000

Highlights of 2019:

- We performed 7 plays in 61 performances at the theatre to audiences of more than 4,100.
- Our members met regularly for social play readings.
- Our Acting Class Head Tutor Leilani Boughton and tutors conducted hundreds of acting class sessions to 80 plus students, and a wide range of summer workshops were organised and presented in January 2019. Early in 2019 we employed Alexandra Comber as casual Administration Assistant and we now have a functional office.
- Our Life Member Training Scholarship Scheme continued and a number of members benefitted from drama training.
- Aimee Cavanagh was nominated for a CONDA Awards in Excellence in Sound Design for It's a Wonderful Life and a number of our members were nominated in various categories for their work at other local theatre companies.
- We received a grant under the Volunteer Grants Program which has been put to good use with a number of equipment items including an automated external defibrillator (AED).
- We continued our involvement with the Maitland Community Corrections scheme which provides community service workers each Saturday morning for our working bees.
- We had a long and successful association with the Maitland Visitor Information Centre which came to an end in December when MVIC ceased ticket agent services. We have now set up our own ticketing using EventBrite and JoinIt for Season Tickets and memberships.

Sadly this year marked the passing of two members and supporters of the theatre – life member Doug Pyle OAM and patron Bob Geoghegan.

We can't rest on our laurels, and to continue to improve our theatre we need the ongoing active support of our members and the community.

TREASURER'S REPORT

I have pleasure in presenting to this Annual General Meeting the financial report for the year from 1 January to 31 December 2019. Briefly, the results for 2019 are as follows:

- Total Income was \$138,430 1.
- 2. Total Other Income increased by \$4,552*
- 3. Total Cost of Sales decreased by \$7,345*
- Total Expenses increased by \$16,397* 4.
- Balance of General Funds (Current Assets) stood at \$124, 890 5.
- 6. Total Equity stands at \$750,875
- Net Profit for 2019 was \$13,082 7.

Maitland Repertory Theatre produced and performed a total of seven productions in 2019. A detailed analysis of the results of each production is listed in the separate sheet, MRT Main Performance Profit and Loss Statements 2019. Here is a summary:

Notes to the Accounts 2019

This financial report is a special purpose financial report prepared 1. in order to satisfy the financial reporting requirements of the Associations Incorporations Act of New South Wales. The committee has determined that the association is not a reporting entity.

The financial report has been prepared on a cash basis and is based on historical costs and does not take into account changing money values or, except where specifically stated, current valuations of non-current assets.

The following significant accounting policies, which are consistent with the previous period unless otherwise stated, have been adopted in the preparation of this financial report.

- a. Cash and cash equivalents include cash in hand, deposits held at call with financial institutions, and other short term highly liquid investments with original maturities of six months or less.
- b. Grant and donation income is recognised when the entity obtains control over the funds, which is generally at the time of receipt.
- c. Revenues, expenses and assets are recognised inclusive of the amount of GST, as the Theatre is not registered for GST.
- 2. Total Income increased by \$7,063 due to increased ticket prices and sales in 2019.
- Commission of \$4,752 (2018 \$4,676) represents 5% (counter 3. sales) / 7.5% (web sales) of gross ticket sales through Maitland Visitor Information Centre plus GST.
- Cost of Sales decreased by \$7,345. The main components of this 4. change were a decrease in Royalties due to prepaid 2019 royaties in 2018 and decreased play production costs.
- Total Other Income increased by \$4,552. The main component 5. was the increase in Acting Class income which reflects increased prices for Acting Classes.

- Donations were made in 2019 to MDCEA and a Masonic Fundraiser for cancer \$2,229 (2018 \$1,198).
- Total Expenses increased by \$16,397. The main components of 7. this change was increased expenditure on Wages and Salaries.
- The Theatre received grant funding of \$4,950 from the Volunteer 8. Grant Scheme for small equipment.
- Refer to the separate Building Fund Activity Statement for details 9. of the Building Fund.
- 10. Land and Buildings are reported at cost. As at 19 February 2019 the buildings are insured for \$1,493,500 and contents for \$267,800.
- 11. Keith Compton of Comptons Accounting Pty Ltd will audit the financial records. Expected completion May, 2020.

Statement by the Management Committee

The Management Committee of Maitland Repertory Theatre Inc. is responsible for the preparation and fair presentation of the financial report, and has determined that the basis of preparation described in Note 1 is appropriate to meet the requirements of the Associations Incorporations Act of New South Wales 2009 and is appropriate to meet the needs of the members. The committee's responsibilities also include such internal control as the committee determines is necessary to enable the preparation and fair presentation of a financial report that is free from material misstatement, whether due to fraud or error.



MRT ACTING CLASSES UPDATE

Maitland Repertory Theatre's Acting Classes had another fun and rewarding year. Towards the end of 2019 we had approximately 85 students across our five drama classes and two musical theatre classes. The number stands at 80 at the start of the current term. At the start of 2020, we made the decision to not run musical theatre classes for Term 1 but plan to bring these back for Term 2.

We held our first Improvisation tournament in April which gave our students a great opportunity to work on their improv skills and build confidence performing in front of an audience. The theatre currently employs seven regular tutors, (two of whom are new), and three casuals. We look forward to seeing what they can bring to our classes for 2020.

Our 2019 production of Snow White was a great success and was extremely fun for students and audience members. We received positive feedback from audience, cast and parents and we hope to bring another great production to our audiences this coming year.

REAMUS YOUTH THEATRE UPDATE

Early in 2019 Reamus members participated in an eight week Shakespeare sonnet project which culminated in the recording of each individual sonnet. These recordings were then published on Youtube and our Facebook page.

Our 2019 production was Shakespeare's *Taming of the Shrew*. While we dropped a few cast members during the rehearsal process (due to lack of commitment), we did recruit some new actors into the mix and the show came together well. The show drew lots of praise from our audience. One person who gave feedback said he had travelled up from the Blue Mountains for three years in a row to see the Reamus yearly Shakespeare production and commented on how lovely it was to see the progress and development of the Reamus members over those three years.

Taming of the Shrew also had two additional school show performances. These performances catered for the entire body of students from Year 8 at St. Peter's in Maitland.

We finished out the year with another shorter sonnet project which again culminated in video recordings of our finished work and these recordings were again made accessible to the public.

2019 saw a major growth in the involvement of Reamus members across other Maitland Repertory shows. Members of Reamus Youth Theatre performed on stage in every 2019 mainstream show, except for the junior show.


We are currently in the process of selecting the end of year play for 2020. This is always a more difficult play to select as we like to get it right to please our audiences and our regular supporters.

We still mail out over 900 postcards for most shows but because of increasing postage costs, no more addresses are being added to the list, except for season ticket holders.




About Maitland Repertory Theatre
